SOURCES OF LAW

The law on health and safety at work is a combination of criminal law and civil law. Criminal law contains a number of different strands and certain subtle differences exist between English and Welsh law, and the law that applies to Scotland and Northern Ireland. Criminal law has developed over centuries and is thus an amalgam of statutory law, common law and European Union law.

Statutory law consists of laws that have been made by an Act of Parliament. Governments may introduce a Bill to update existing laws or develop new ones to respond to changes in society. A Bill is debated in Parliament and once passed is drafted into law. Regulations and Orders also form part of statutory law.

Common law is also known as case law and is made by judges in the course of hearing individual cases. This is known as the system of "precedent". Precedent effectively means that a legal decision that was reached in a particular case will then apply to all subsequent similar cases. In theory this gives the law some degree of flexibility as it is allowed, so to speak, to respond to changes in public standards or society in general. At common law an employer has a "duty of care" towards employees. The courts have interpreted this as having a duty to:

- provide and maintain a safe place of work
- develop safe working methods
- provide competent fellow workers
- provide effective supervision.

The development of case law still remains an important source of law. This has particularly been the case in case law in respect of stress at work. A statement of law made by a judge in a case can become binding on later judges and can in this way become the law for everyone to follow. When a judge decides

a case, he will state his reasons for that decision. The pronouncement (precedent) must be made from a court of sufficient seniority. It is the higher courts which issue binding rulings and the lower courts must follow them. Other decisions by lower courts are said to be "persuasive".

Since the introduction of the European Communities Act 1972, European law has had an increasing effect on UK law. European law consists of primary legislation (such as the Single European Act), secondary legislation (made up of directives, legislation and decisions) and case law. Any established UK law that contradicts European law will be overruled by its European equivalent through the European Court of Justice in Luxembourg.

Civil law is that section of the law that deals with disputes between individuals or organisations. Although it is much more wide-ranging it produces fewer cases in court as most are settled before they reach court in "out of court settlements". Civil law includes the law of torts. Torts are civil wrongs, i.e. forms of unacceptable behaviour actionable in court, which includes injuries suffered as a result of accidents at work.

Civil law has developed in a similar way to the development of criminal law, i.e. through a mixture of statutory law made by Government and 'precedent' created in earlier cases.

One crucial difference between civil and criminal law is that the "burden of proof" required is lower in a civil case. A criminal case must be proved "beyond reasonable doubt" whilst a civil case only has to be proved on the "balance of probabilities", i.e. whether it is likely that the defendant is guilty.

STATUTORY LAW

Acts of Parliament are the primary source of law in the UK and with the exception of European law; an Act of Parliament is the supreme law of the land. Some Acts are brought into force by the use of statutory instruments known as "Commencement Orders", which activate parts of an act on a given date.

An Act may confer power on a minister to make new or additional law by means of regulations. Health and safety regulations are made under s.15 of the HSWA and are mostly designed to supplement and strengthen the provisions of the Act. A breach of a duty imposed by regulations is punishable as a criminal offence. Additionally, a breach may give rise to civil liability, except insofar as the regulations provide otherwise. It is possible for them to supersede specific provisions of the parent Act.

Orders are normally used when ordinary statutory instruments are inappropriate. Modern practice is to confer on the appropriate minister the power to make Orders. Section 85 of the HSWA enables the Secretary of State to make Orders in respect of health and safety. The Regulatory Reform Act 2001 enables the Government to make an Order to amend or repeal a provision in primary legislation and can so reform entire regulatory regimes (particularly where a legislative burden stems from overlapping legislation). Proposals must go through an extensive consultation process.

Local authorities have the power to pass bye-laws for the administration of their own area. This must be within the powers conferred by the parent Act of Parliament and must also be reasonable. It is possible to challenge the validity of bye-laws in court.

The HSWA is the main legislative framework governing the health, safety and welfare of all those at work and others who may be affected. The aim of the HSWA and legislation made under it is to encourage everyone to achieve high standards with respect to health and safety. The HSWA consists of four parts, as follows:

- Part 1 relates to health, safety and welfare with respect to work.
- Part 2 relates to the Employment Medical Managery Service (EMAS).
- Part 3 amends laws relating to building regulations.
- Part 4 contains a number of miscellaneous and general provisions.

Some contracts may come under the rules of the CDM Regulations and as such, Mervyn Lambert Plant would seek to discharge its duties as with any other legislation. Generally, MLP would not be a primary duty holder (Principal Contractor, Designer etc) However, our remit may fall under the CDM term "Worker" In such cases we would seek to undertake the following:-

The worker is an individual working for, or under the control of, contractors on a construction site. They have their own duties as well as their employers.

REGULATIONS

Once a European Regulation has been passed it becomes part of the laws of Member States and overrides any contrary domestic provision.
